**NOTE: All Vendors**, in compliance with Arizona Law, must submit a copy of their Liability Insurance Coverage showing the dates of the specific event.

Coverage must be \$1,000,000.00 or greater for this event listing the Payson Rodeo Committee, Inc. , P.O. Box 784 Payson, AZ 85547, as additionally insured. All food vendors submit your current annual

Health Certificate from Gila County.

A Temporary Food Booth permit for Special Events is a requirement if you do not have an annual Health Certificate from Gila County.
